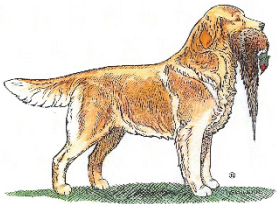

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

No entries will be accepted by phone, email, fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Kevin or Dee Dee at SniffyTrialSec@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$35.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

GRCA is offering a wait list for the Detective class to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **25 entries** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to August 9, 2023 5:00 pm. No entries may be withdrawn with a refund after closing on August 9, 2023 5:00 pm. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

A **warm-up area** will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving the dog.

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place at the start line with the judge. The judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors on rubber matting, carpet, linoleum, or concrete, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. This trial site will not be used for Scent training one week before the trial.

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state “No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area”.

Spectator Area. This will be left up to each judge.

Crating space. There will be designated crating areas but be prepared to walk to search areas.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Reactive dogs

Chapter 3 Section 30. Special Accommodations for Certain Dogs. *Clubs are not to make special accommodations for certain dogs (such as dogs determined by their owners to be “reactive”). Clubs may not advertise a “red bandana” policy in Premium lists or printed materials or impose such a policy in the briefing.*

SPECIAL AWARDS

Special awards will be given over a combination of two days.

You must enter classes both days to be eligible for the special awards.

High in Trial over two days

Only teams who participate in the same difficulty level in all elements offered for that level and qualify in each are eligible to win High in Trial. One High in Trial winner is chosen from the Novice (A & B are the same class), Advanced, Excellent & Master classes if the dog qualifies in all 4 classes at that level.

High Combined over two days

Only teams who participate in the same difficulty level in all elements offered for that level and HD and qualify in each are eligible to win High Combined. One High Combined is chosen from the Novice (A & B are the same class), Advanced, Excellent & Master classes the dog qualifies in all 4 levels classes plus HD.

The High in Trial & High Combined is determined by adding the team's times across the elements. The faster-finishing team will win. If there is a tie the winner will be determined by a flip of a coin. Teams without faults take priority.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. GRCA and its agents, employees, etc., will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. GRCA reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against GRCA or any official thereof.

PUBLICATION RIGHTS: By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club/GRCA and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times. (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS: No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

CONFIRMATION OF YOUR ENTRY: You will receive a confirmation email of your entry with an amband number at least one week before the trial closes. Check over your confirmation for any corrections needed. You will receive a schedule at least one week before the trial dates. If you do not receive a confirmation email, notify the secretary before the trials closing date.

EXHIBITOR CHECK-IN: Once the time and location for check-in is determined all exhibitors will be notified by email.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance at the Club event. On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its Officers, committee, grounds owners, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
